New Hospital Programme Review

This government is fully committed to an NHS estate that is fit for the future. However, from our first weeks in office, it was clear that the New Hospital Programme (NHP) was undeliverable, unaffordable, and estimated costs had risen by billions. Combined with the incredibly challenging fiscal inheritance that the Chancellor set out in her statement on 29 July, it has become clear that the challenges facing the NHP, and the wider public finances, are much more severe than we were aware.

The previous Government failed to hold a Spending Review in their last few years of office, this created a vacuum which allowed previous Health Secretaries to allude to £20billion of investment in the NHP that was not there. This government wants to see the NHP completed, but we are not prepared to offer people false hope about how soon they will benefit from the facilities they deserve. We must reset the NHP to put it on a sustainable footing. For this reason, I requested an urgent internal review of all hospitals in the NHP.

The review, which is being jointly conducted by HM Treasury, the Department of Health and Social Care and NHS England, will be completed as soon as possible to reach a swift conclusion on the changes needed to ensure an affordable and realistic delivery schedule. This will recognise the delivery and market constraints that impact all major capital programmes, as well as the need to continue to deliver the most advanced and most urgent hospitals to a realistic timeframe.

The Terms of Reference for the review, which have been agreed with the Chief Secretary of the Treasury, are attached, and confirm which schemes are out of scope and will continue to progress at pace.

Central to the review is the understanding that the hospitals built primarily from Reinforced Autoclaved Aerated Concrete (RAAC) need to be replaced as a priority, to protect patient and staff safety. While the review is taking place, all schemes within the NHP will be

supported to continue to make progress; schemes with an approved Full Business Case for their main scheme will not be within the scope of the review.

I will carefully consider the findings of the review to provide a thorough, costed, and realistic timeline for delivery to ensure we can replace the crumbling hospital estate in England, and ensure staff and patients have access to the facilities they deserve. The review will feed into the Spending Review process, where decisions on the outcome will be taken in the round and the Government will confirm the outcome of the review as part of that process.

Because we inherited a programme that was unfunded beyond March 2025 and a wider fiscal inheritance that was hugely challenging, we may have to consider rephasing schemes so that they can be taken forward as fiscal conditions allow. A structured and agreed rolling investment approach will mean proceeding with these schemes will be subject to investment decisions at future spending reviews.

We understand that all MPs with a constituency interest will be keen to meet to discuss the outcome of the review and any impacts for constituents. We are considering the best way to take this forward when Parliament returns after conference recess. Details for these meetings will be shared in due course.

New Hospital Programme Review – Terms of Reference

Purpose

The review aims to consider the options for putting the New Hospital Programme (NHP) on to a realistic, deliverable, and affordable footing. The review has been requested by the Chancellor of the Exchequer and the Secretary of State for Health & Social Care and will be jointly led and resourced across Department of Health and Social Care (DHSC), NHS England (NHSE) and HM Treasury (HMT).

Governance and arrangements

The review will be led by the director for delivery, performance, and assurance in the DHSC NHP Sponsor team, along with senior colleagues from the NHSE Delivery team and HMT. A steering group, including representation from HMT, Cabinet Office and the Infrastructure and Projects Authority (IPA), will be convened to oversee the review, directed by the Senior Responsible Owner for the NHP, Chief Financial Officer in NHSE, Director General for Finance in DHSC and senior officials in HMT, reporting to the Permanent Secretary of DHSC. The review will conclude as soon as possible and will be submitted to the Secretary of State for DHSC and the Chief Secretary to the Treasury for consideration.

Scope of the review

The review will assess the appropriate schedule for delivery for schemes in the New Hospital Programme in the context of overall constraints to hospital building and wider health infrastructure priorities, whilst also looking at where improvements can be made. Out of scope will be schemes that have approved Full Business Cases, and any associated phases that have specific commitments. The review assumes these will continue to their current delivery timelines. Also out of scope will be the critical seven hospitals with Reinforced Autoclaved Aerated Concrete (RAAC), which will proceed at pace due to the substantive safety risks associated with these.

In scope will be all remaining hospitals in the NHP without Full Business Case approvals for their main build phase. The review will present a full range of options to be taken forward for the overall size and ambition of the programme to provide a clear approach for the programme going forward.

The review will feed into the Spending Review process, where decisions on the outcome will be taken in the round and the Government will confirm the outcome of the review as part of that process.

Approach to review

Key data will be collated for each of the hospitals falling within the scope of the review, including criteria around: clinical outcomes, deliverability, cost, and estate condition. Data will be drawn from existing sources where possible. Where the information is not held, or up to date, further data may be requested from Trusts or Regional Teams.

The hospitals in scope will be prioritised according to the criteria. The review will look at the possible timelines for delivery for each scheme, along with clinical considerations, risk and cost profiles and present a range of options to be taken forward. Options and recommendations for phasing of the programme will then be established for ministers to consider.

The recommended options for scope, size, and phasing will be supported by confirmation of the optimum approach for delivery, underpinning clinical assumptions, and the associated commercial strategy.

Deliverables

The review will conclude as soon as possible, with a series of options agreed by officials in DHSC, NHSE, the Infrastructure and Projects Authority (IPA), and HMT.
